

AGREEMENT BETWEEN THE  
**KENTUCKY EDUCATIONAL DEVELOPMENT CORPORATION**

**BIMBO BAKERIES, USA**

This is an amended contract. The original contract contained a clerical error.

This agreement is made and entered into the 1st day of August, 2015, by and between the **Kentucky Educational Development Corporation (KEDC), 904 Rose Road, Ashland, KY 41102-7104**, and **Bimbo Bakeries, USA, 1811 Taylor Avenue, Louisville, KY 40213**. KEDC is an educational cooperative organized under the Interlocal Cooperation Act and providing various services to its member school districts. KEDC is also acting as fiscal agent for all KPC members including the following similarly organized Kentucky educational cooperatives that offer bidding services:

- Green River Regional Educational Cooperative (GRREC)
- Northern Kentucky Cooperative for Educational Services (NKCES)
