

AGREEMENT BETWEEN THE  
KENTUCKY EDUCATIONAL DEVELOPMENT CORPORATION  
AND

URETHANE OF KENTUCKIANA, INC. dba INSULATED ROOFING CONTRACTORS

This agreement is made and entered into the 1<sup>st</sup> day of October, 2023, by and between the Kentucky Educational Development Corporation (KEDC), 904 Rose Road, Ashland, KY 41102-7104, and Urethane Of Kentuckiana, Inc. dba Insulated Roofing Contractors, 326 Mt. Tabor Rd., New Albany, IN 47150. KEDC is an educational cooperative organized under the Interlocal Cooperation Act and providing various services to its member school districts. KEDC is also acting as fiscal agent for all Kentucky Purchasing Cooperative members including the following similarly organized Kentucky educational cooperatives that offer bidding services:

- Central Kentucky Educational Cooperative (CKEC)
- Green River Regional Educational Cooperative (GRREC)
- Northern Kentucky Cooperative for Educational Services (NKCES)
- Ohio Valley Educational Cooperative (OVEC)
- Southeast/South-Central Educational Cooperative (SESC)
- West Kentucky Educational Cooperative (WKEC)

The original Agreement commenced on June 14, 2012 and will expire on October 01 2023. KEDC elects to exercise the right to extend the term for up to 180 days to continue a source of supply until an updated pricing structure can be submitted (section 5 of the bid Supplemental Instructions and Terms). The maximum term of this contract renewal shall be 180 days. This agreement incorporates the complete Project Manual for Sprayed Urethane Roofing Systems, Urethane Of Kentuckiana, Inc. dba Insulated Roofing Contractors' bid response, and Amendments by reference.

Upon the signature of an authorized officer of KEDC and an authorized representative of the above named company or corporation, this agreement is hereby executed.
